## **Previous Report in Oct 2019 - MAINTAIN BUY**

PLC's earnings for 2QFY20 was in line with expectations on the back of lower impairment charges, mainly led by impairments peaking in 1QFY20 coupled with the efforts of the debt collecting team. Despite loan book growth on a downward trajectory of 1.6%YTD, NIMs improved to 11.1% benefitting from the repricing of high yielding deposits. With our earnings update published on 29<sup>th</sup> Oct 2019, we maintained our target price at LKR 18.0 with a recommendation to **MAINTAIN BUY**.

### PLC REACHES TP OF LKR 18.0 for FY20E; TP LKR 20.0 for FY21E; HOLD

PLC reached First Capital Research TP of LKR 18.0 on 19<sup>th</sup> Nov 2019 and has remained at the same level since then. The counter outperformed the market since our last report on 29<sup>th</sup> Oct 2019, while gaining by +8% from LKR 16.6 while the benchmark ASPI index appreciated by +3%. Comparably, PLC's share price appreciated by +10% over a 52-week period while ASPI appreciated by a marginal +1%. Furthermore, with impairments peaking in 1QFY20 we expect the recovery in non-performing loans to continue during 2HFY20E with the expectation of a gradual rise in business activity post presidential election. Thereby, we rollover valuation for FY21E with a target price of LKR 20.0 and total return of 15% (AER of 12%). **DOWNGRADE TO HOLD**
