

# First Capital Equity Fund

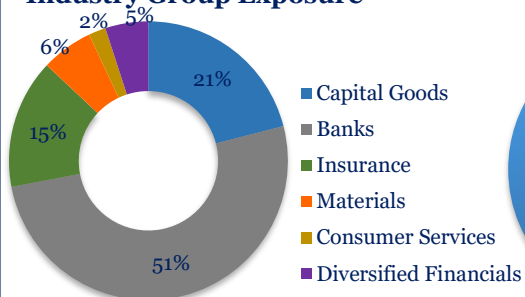
Fact sheet as at 31 May 2021

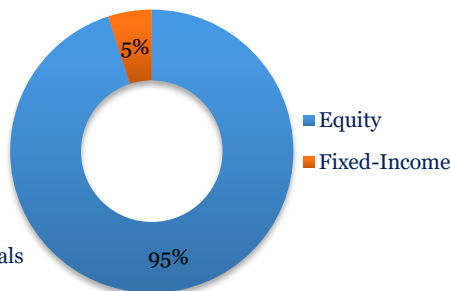

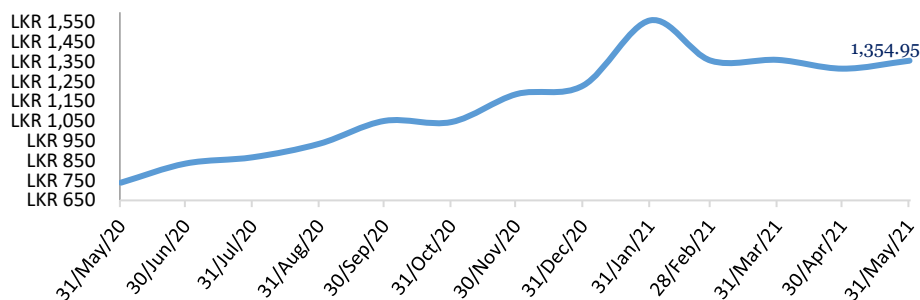
## Industry Group Exposure



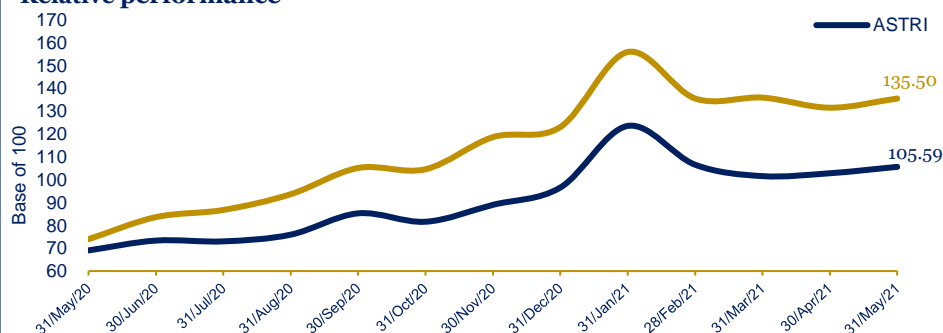
