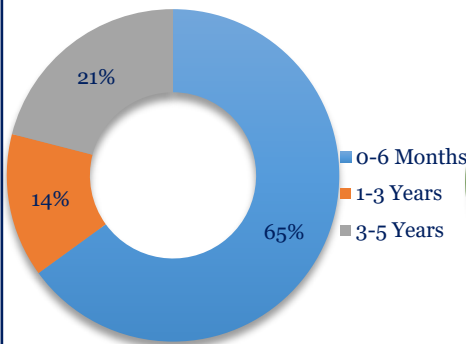

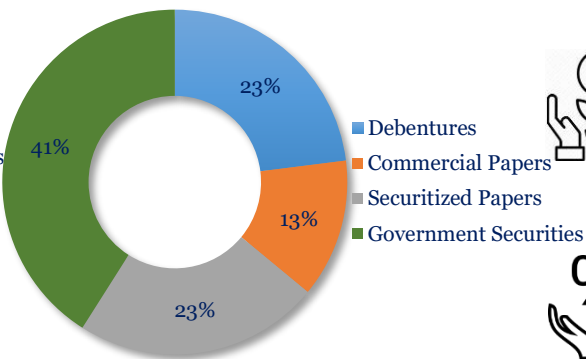
First Capital

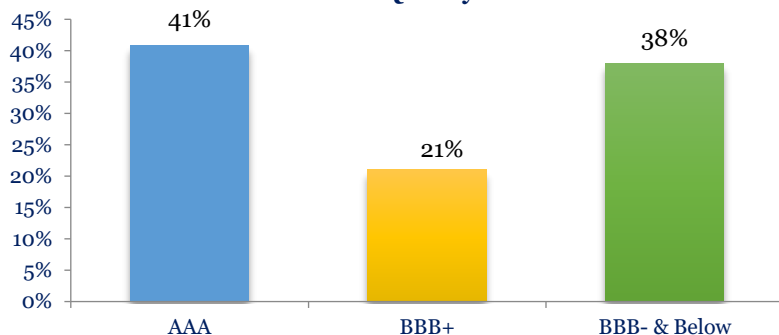
