Following is a summary of goods which are subject to a import suspension with effect from 23rd August 2022

Goods subject to suspension	Affected counters	Impact
Milk & cream, condensed milk, Buttermilk, Yoghurt	LMF, LAMB, CIC	Positive impact allowing demand to expand.
Chocolate and other food preparations containing cocoa	CCS, CARG,SUN	Negatively impacts company's ability to import cocoa based products for frozen confectionary production.
Undenatured ethyl alcohol of an alcoholic strength by volume of less than 80% vol; spirits, liqueurs and other spirituous beverages.	LION, DIST	Positively impact demand for locally brewed liquor. Negatively impact the ability to import value added foreign liquor.
Pebbles, gravel, broken or crushed stone, of a kind commonly used for concrete aggregates	AEL, ASPH	Negatively impacts business operations directly affecting cost owing to restrictions.

Limestone flux; limestone and other calcareous stone, of a kind used for the manufacture of lime or cement.

TKYO

Negatively impacts as the primary raw material of cement production is subjected to import suspension.

Tubes, pipes and hoses, and fittings therefor (for example, joints, elbows, flanges), of plastics.

RICH, APLA

Positive impact allowing demand to expand.

Articles of apparel and clothing accessories, of leather or of composition leather

SHL, SIL

Negatively impact the company's ability to import finished clothing. (International brands)

Bricks, blocks, tiles and other ceramic goods of siliceous fossil meals (for example, kieselguhr, tripolite or diatomite) or of similar siliceous earths.

RCL, LWL, CERA

Positive impact allowing demand to expand.

Aluminum bars, rods and profiles.

ALUM, LALU, PARQ

Positive impact allowing demand to expand.

Air conditioning machines, Refrigerators, freezers and other refrigerating or freezing equipment, electric or other

SHL, SINS, ABAN

Negative impact as it restricts the sale of such items.

Telephone sets, including telephones for cellular networks or for other wireless networks

DIAL, SLTL

Negative impact as it restricts the sale of such items.
