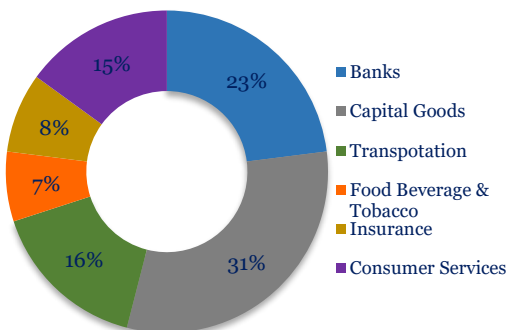

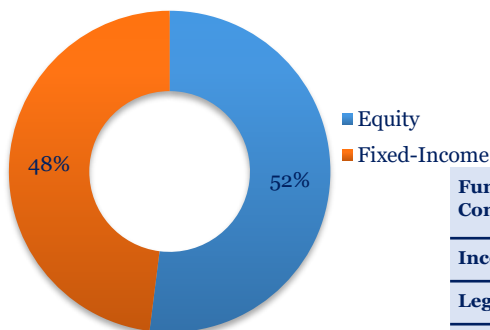

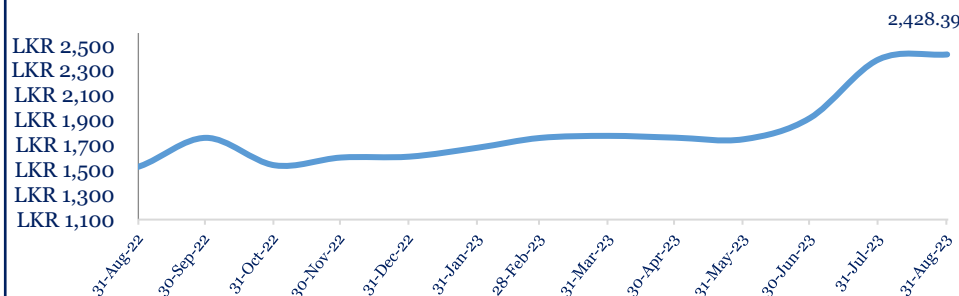
## Industry Group Exposure



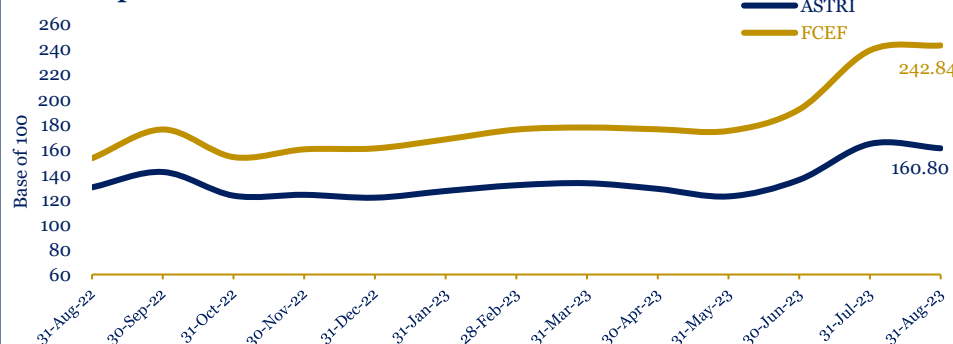
