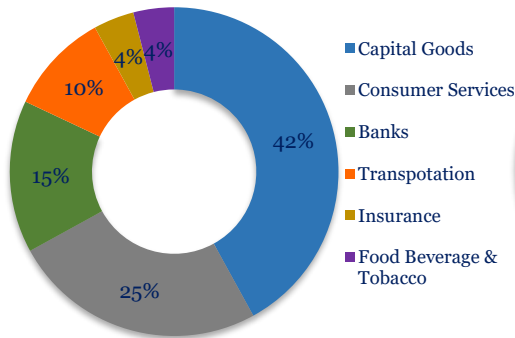

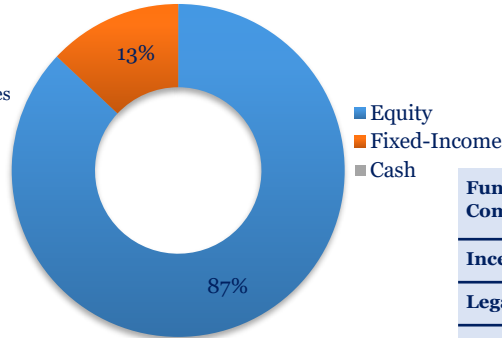

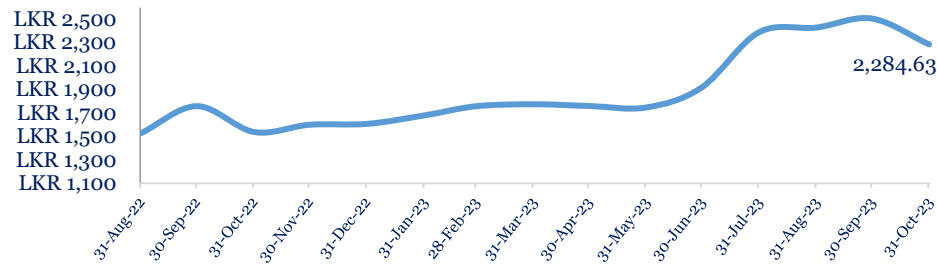
## Industry Group Exposure



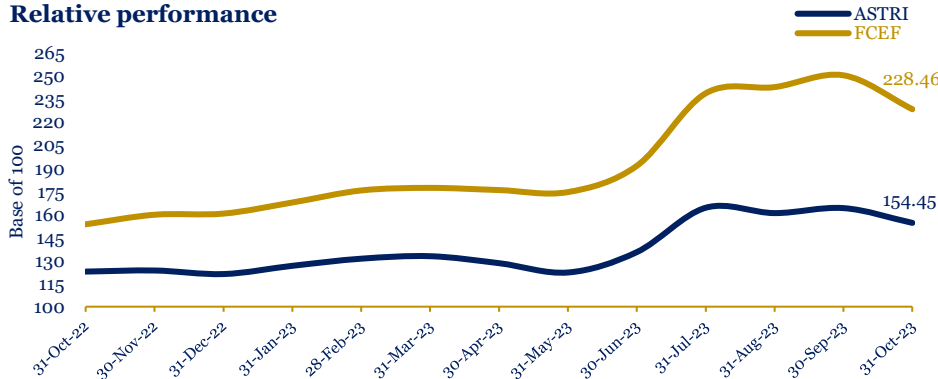
## Asset Allocation
